

# **SHORT TERM RENTAL - GUIDE**

## **Getting Started**

The City of Simpsonville Zoning Ordinance defines short-term rentals as the rental of an un-hosted property for an overnight stay of less than 30 days at a time to one or more guests.

In order for the application to be accepted, the property must be located in one of these zoning districts.

- R-Lo Residential Low Density
- R-Mid Residential Medium Density
- R-Hi Residential High Density
- R-OI Residential Neighborhood, Office & Institution
  - \*Apartment complexes are prohibited from operating STR To see what the subject property is zone, use the City Zoning Map

#### **APPLICATION PROCESS**

- 1. This guide will provide answers on the regulations for operating short-term rental in the City of Simpsonville. You will be asked to acknowledge that you have read this guide prior to moving forward in the application process.
- 2. An application fee is not required except for Short-term rentals found operating after <u>January 12, 2026</u>. For short-term rentals found operating after this date without city approval, an application fee of \$250.00 will be required
- 3. City Staff will review the application and send comments back to the designated person on the application within approximately 10 business days.
- 4. If the short-term rental application is approved, a <u>business license</u> is required in addition to the short-term rental permit. #### RENEWAL APPLICATION PROCESS

It is your responsibility to renew your short-term rental permits and business license through our online application portal prior to April 30<sup>th</sup> each year. If you fail to do so before the deadline any year, you will be assessed the \$250 application fee.

#### **ACCOMMODATION TAX**

The local accommodation tax rate is 3%. It is due by the 20<sup>th</sup> of the month for the previous month.

### SHORT-TERM RENTAL APPLICATION REQUIRMENTS

These items will be requested during the application process in the permit portal:

- Name, address, & 24 contact information of STR agent
- Proof of ownership of property
- Owner's signature they have read the Simpsonville STR Regulations
- Owner acknowledges their property will be used in accordance with STR Regulations.
- Proof of property & liability insurance
- A written certification that the designated agent will perform their duties specified in the STR Regulations
- Properties located within a HOA community, confirmation they have received the appropriate approval from the board/management company allowing STR as a use
- Owner's agreement to allow City personnel to inspect the property as may be necessary for enforcement.
- Provide a copy of Written Agreement between owner and renter
